RATES

- **ASL/English Jobs:**
 - \$50/hr. with a minimum of 2 hours during the 7 am to 5 pm shift
 - \$60/hr. with a minimum of 2 hours during the 5 pm to 12 am shift
 - \$70/hr. with a minimum of 2 hours during the 12 am to 7 am shift
- **Trilingual Jobs (ASL/English/Spanish):**
 - \$55/hr. with a minimum of 2 hours during the 7 am to 5 pm shift
 - \$65/hr. with a minimum of 2 hours during the 5 pm to 12 am shift
 - \$75/hr. with a minimum of 2 hours during the 12 am to 7 am shift
- **Jobs where Mexican Sign Language (LSM) is required:**
 - \$65/hr. with a minimum of 2 hours during the 7 am to 5 pm shift
 - \$70/hr. with a minimum of 2 hours during the 5 pm to 12 am shift
 - \$75/hr. with a minimum of 2 hours during the 12 am to 7 am shift

Traveling Time

When the job assignment is within a 25-mile radius, traveling time is not billed as work hours (however, driving mileage round-trip is billed). When the job is past the 25-mile radius, the travelling, round-trip time will be billed **in addition** to mileage. In all jobs, mileage and parking fees will be added.

Cancellations

48-hour cancellation notice is required when the job is within the 25-mile radius. 72-hour cancellation notice is required when the job is outside the 25-mile radius. Cancellations will be billed for the two-hour minimum.

Team Interpreter

For occupational safety reasons, reservations approaching 75 minutes or more may require two interpreters. Physical and mental fatigue can therefore impact on the interpreter's well-being, the rendering of the message, and the consumer's benefits. I will advise you in advance if a team interpreter is required. Breaks and passive interpreting team person are also paid during this time. If the original job request did not require two interpreters, there will be a 10-minute tolerance interpreting time for events going over 75-minutes' time. If the job continues without a team at working minute 76, the job will be billed double. If the job continues after 121 minutes without a team, I will ask for a required 30-minute double time paid break, if a team interpreter still has not shown-up, from this point forward, the job triples its cost.

Lunch

If the job requires you to work in broken shifts (job starts before lunch and continues after lunch), the lunch time is billed as working time except when the labor laws indicate otherwise.
